I run game servers and have for a long time and I think I know if someone is using or not. For crying out loud I make games I know when things are just to obvious. I'm guessing this person was your friend so, you decided to act like a jacka**. I really don't care and thats that. Oh and as far as the whole Comcast thing goes, I doubt they would really care but, I'm sure they would like to know your trying to get newbs to hack my system. Good luck on that though your never get through. You want to talk about me saying I'd blow your system yet, you're trying to get people to hack my server you are the most ironic person I have ever known.

I don't need to trace a public IP to you; I'm certain Vivendi did a background check on you before you were hired, so it's only a matter of asking your Human Resources Department which of their employees is a former Marine who served between 1992 and 1998, and/or who had a connection to irc.black-cell.net at 2:05 PM on Wednesday, August 2. I could possibly get a legal document from the Law office I work at to facilitate this. Second, security would not throw me out on my ass for reporting a crime. This is not a mere "internet argument"; we both live in Los Angeles, so there is an imminent threat in your declaration that you would like to kick my ass. What you said may constitute a form of Verbal Assault, which is a violation of the imminent lawless action exception to the First Amendment right to free speech. Security's purpose is to prevent violence inside the building, so their presence would be REQUIRED to prevent any kind of altercation from transpiring between us. You may be right, however, in thinking they would not allow me to be in the same room as you. However, an assault conviction would not look good on your employee record or your résumé. Regarding your baseless accusations that I am trying to find people to hack YOUR server: first, the word you're looking for is "hypocritical", and second, I have not, am not, nor will I ever be in the process of recruiting people to attack your server. That would be a pointless and illegal action. I also doubt you can produce any physical evidence (at least, nothing that isn't falsified) proving that I have a hand in any such malicious actions.
