Its called disabling someone. If someone holds a gun to your head, you hit their hand or gun to point in a safe direction then pry the gun off them, dispose of it, or use it against them You don't neccessarily have to shoot them.

If you do shoot someone, however, you don't have to shoot to kill. Police learn to aim for non-vital, but disabling parts of the body to shoot.

If someone attacks me with their bare fists, knife, gun whatever, I get the better of them so they can't harm me in any way, I'm NOT going to proceed and beat the shit out of them untill they die.

If it costs less than a dollar to kill an attacker, it costs less not to kill him. If you defend yourself against an attacker, but proceed to kill him, then that could be deemed as "overkill" (non legal term btw). You could be liable for that.

The idea is to send people to prison and rehabilitate them. Not just kill them on the spot. Thats why prisons have libraries, teachers, and thats why you can learn a trade if you are in prison long enough so when you are released, you won't resort to crime.

The double-tap, like Nodbugger said, is simply a pair of shots fired in extremely short succession aimed at the "A" section of an IPSC torso target.

As for the MP5... I have personally never gotten to use one, yet. However, I do know that some variants of the machine pistol have what is called an "automatic-double-tap" (in essence, a two round fully automatic pair of shots), which essentially plugs two rounds into relatively the same space (because of the obvious recoil of each shot) in a smaller time frame than your finger could ever do. Do I really need to tell you what happens when two shots hit someone in a fractal millisecond timeframe in just about the same location? I thought not.

But then again, it depends on your definition of "take down a target". Because there are quite a few ways to do that (fatal or non-fatal) effectively with an automatic double tap. If you're trying to incapacitate without killing the person, you might aim on the lefthand side of the "C" or "D" section of an IPSC target. You'll likely puncture a lung, but dual shots will have your problem on the ground in shock, giving you the oppurtunity to manually disarm or administer aid or what have you. If you're trying to cause a fatal shot, you need to aim at parts of the body that would case imminent death with no chance of them misfiring and hitting you, such as a pair of bullets penetrating the spinal cord at the neck or Just in front of the cerebellum.

Shooting them with a bullet is less expensive, obviously, but it is much messier and unless you shoot someone directly in the head, it would be considered cruel and unusual punishment, which, last time I checked, is against the very rules of the Constitution. A lot of people would consider bullets inhumane regardless of how they were used anyway. Thus, the method prevents additional controversy around an already touchy issue.

Also, I was commenting on the current method of executing prisoners, which is the injection method.
